PROCEEDINGS

I CALL TO ORDER

The Chairman, Mr. Ernesto O. Ang, presided over the meeting and called the meeting to order. Mr. Karlvin Ernest L. Ang, Corporate Secretary, recorded the minutes of the proceedings.

II CERTIFICATION OF NOTICE AND QUORUM
